NECOPA was founded in October 2010 at the School of Public Affairs and Administration (SPAA) at Rutgers—The State University of New Jersey as an annual, regional conference of the American Society for Public Administration.

As an organization, NECoPA provides support for universities in the northeast region as they work to plan and host the annual conference. This event is intended to provide educational opportunities for scholars, practitioners, and students interested in the scholarly exchange of public administration research, best practices, and networking. Participants come from around the country and the world.

To date, NECoPA conferences have been held at Rutgers—The State University of New Jersey (2010), John Jay College-CUNY (2011), the University of Massachusetts – Boston (2012), the University of Delaware (2013), the University of New Hampshire in Portsmouth (2014), George Mason University's Arlington Campus (2015), Penn State Harrisburg (2016), the University of Vermont (2017), the University of Baltimore (2018), and the LIU Brooklyn (2019). A virtual version of the conference was hosted by Suffolk University (2020) and University of Albany, SUNY (2021). NECoPA Inc. hosted a virtual version of NECoPA in 2022 and 2023. In 2024, NECoPA returned to an in-person conference held at Pace University in the heart of New York City.

Rutgers SPAA serves as the official secretariat for NECoPA, playing an integral part in the development of this important organization, which is dedicated to furthering the education of public administration.

Dr. Rajade M. Berry-James is Senior Associate Dean of

Faculty and Academic Affairs and a tenured Professor of Public Administration at VCU's L. Douglas Wilder School of Government and Public Affairs. An elected fellow of the National Academy of Public Administration, she served as past president of NASPAA and holds lifelong memberships in the American Society for Public Administration (ASPA) and Alpha Kappa Alpha Sorority, Incorporated. She earned a B.S. in Business Administration from Rider University (1987), an MPA from Kean University (1993)—with a thesis on comparable worth and pay equity in higher education—and a Ph.D. in Public Administration from Rutgers University-Newark (1999), becoming the first African American to do so. Her dissertation examined affirmative action implementation in higher education, specializing in productive public management.

She has a Ph.D. degree in Public Affairs from Florida International University, a MA in Public Service Management and a BA in Public Administration from Babes-Bolyai University, Romania. She serves as Associate Editor for Public Administration Quarterly and Public Integrity and is the chair of the Northeast Conference of Public Administration.

Dr. Scutelnicu Todoran authored over 40 publications for both academic and practitioner audiences. Her research in the area of gender and social equity has appeared in highly regarded journals in the field. Her most recent book "Managing Gender Inequity in Academia" is published by Routledge, Taylor & Francis. In recognition of her research and professional contributions Dr. Gina Scutelnicu Todoran has been presented with several awards such as the SWPA's Rita Mae Kelly Distinguished Research Award (2025), ASPA New York Metropolitan Chapter's Outstanding Academic/Researcher Award (2023), and the Donald C. Stone Service to ASPA Award (2022). She has been a Capstone Thesis and Doctoral Dissertation advisor for more than 30 students.






## **Kean NAAB floor plan**




